Madison	City of Berea	Brushy Fork Sanitary Sewer Rehabilitation Project	\$588,571	This investment will repair the sanitary sewers in the Brushy Fork are in Berea, and will include pipe lining, manhole replacement, manhole rehabilitation, point repairs, and sewer pipe replacement.
Madison	Madison County Utilities District	College Hill Water Project	\$608,105	This investment will replace 24,800 feet of deteriorating water line, construct a new pump station, construct a new water tank at Waco, and refurbish the water tank at College Hill. The upgrades will improve efficiency, water capacity, and provide a more reliable potable water supply.
Madison	Southern Madison Water District	Bobtown Tank Rehabilitation	\$230,000	Funds will be used to restore the aging 300,000-gallon "Bobtown" water storage tank. The tank will be sandblasted and repainted on both the exterior and interior to ensure it can maintain the quality of the drinking water stored in the tank.

Madison	Southern Madison Water District	AMR Water Meters	\$34,675	This project includes the purchase of 3,000 new Automatic Meter Reading (AMR) water meters for the Southern Madison Water District. These new water meters will provide the district the ability to automatically collect consumption, diagnostic, and status data from water meters, and transfer that data into a central database for billing, troubleshooting and analyzing.
Madison	Southern Madison Water District	New SCADA System	\$19,720	This project includes the purchase and installation of six new supervisory control and data acquisition (SCADA) units for each of the three water tanks and three pump stations in the system. This will allow the district to monitor, gather, and process real-time data from the system.

Estill	Irvine Municipal Utilities Commission	Master Meter Relocation and River Crossing	\$518,058	This project will allow the Estill County Water District #1 and Irvine Municipal Utilities to replace the aging water main, which currently runs between the CSX railroad line and the Kentucky River, and relocate it to the opposite side (west side) of the river, allowing easier access and removing the line from

Garrard	City of Lancaster	Sanitary Sewer Extension	\$548,802	Funds will be invested to construct additional sewer line and a new wastewater pumping station. The project will eliminate two aging, overloaded lift stations (Buckeye Pump Station and Hill Court Pump Station) and will decrease flow in the system's lines by re-routing flow to the new lift station.

Garrard	Garrard County Sanitation District	GCSD Master Plan	1550.000	This project would develop a master plan to provide the Garrard County Sanitation District with a guide to help plan sanitary sewer collection and treatment system infrastructure improvements to meet present and future needs.
