Rowan	Morehead Utility Plant Board	MUPB Lead Removal Program - Phase 1	\$406,319	The Morehead Utility Plant Board will remove approximately 6,000 feet of original water line, dating to the 1930s, that is located within the City of Morehead. The project will ensure compliance with EPA's Lead and Copper Rule by removing portions of the distribution system that contain lead parts and materials.
Rowan	Rowan County Fiscal Court	East Clack Mtn Water Main Extension	\$342,000	This investment will extend the existing line on Rifle Range Road south of the city of Morehead and will provide potable drinking water services to three new customers on East Clack Mountain Road in Rowan County. This project is a continued effort by Rowan Water Inc to provide safe and potable drinking water to those homes that currently have little or no water.

Rowan	Rowan County Fiscal Court	Rowan Water Inc New Permanent Office Generator Project	\$150,000	The project would involve the installation of a permanent emergency generator and automatic transfer switch at Rowan Water's main administrative office, which will allow for the office to remain operational and continue to provide the necessary services to Rowan Water's nearly 7,350 customers. The new generator will also allow for the office to serve as an emergency communication center during the power outages in the local area.

Morgan	City of West Liberty	Sewer Line Replacement Project	\$121,895	Aging sanitary sewer lines on Riverside Drive, Peddler Street, Bellamy Court, Trimble Street, Court Street, Glenn Avenue, and a portion of Broadway will be replaced to reduce the amount of groundwater and stormwater entering sewer pipes. Inspections of the systems manholes and sewer lines will also be conducted.
Morgan	City of West Liberty	Branch Street & Henry Street Line Replacement	\$121,892	This investment will replace a problematic sewage line and manholes in the city of West Liberty from Branch Street to Henry Street. The line causes a bypass to take place during heavy rain events, adding additional stress on pumps located at the wastewater treatment plant.

Morgan	City of West Liberty	Water Quality Improvements Project	\$245,000	This extensive investment will include the construction of a new 47,000-gallon water storage tank to serve the customers in the Hutchinson Road/ McClain Way area. These customers now rely on water from a tank owned by the Kentucky Department of Corrections that services the local prison. Other improvements include a new pump station, new waterlines at a number of locations, new hydrants, meters and more.

Menifee	Menifee County Fiscal Court	Menifee Co Sanitation District Means Area System Rehab	\$108,165	The project will rehabilitate existing sewer infrastructure to prevent inflow and infiltration of stormwater into the sanitary sewer system. The project will include rehabilitation of mainline sewer, service lateral connections, and manhole structures. This project will reduce power consumption at sewage pump stations during rain events by eliminating various points of inflow.
Menifee	City of Frenchburg	Mountain Ridge Road & Ridge Runner Water Main Extension	\$91,150	This investment will provide potable drinking water to approximately 13 new customers and includes the installation of approximately 5,000 feet of new water main along KY-1274, Mountain Ridge Road and Ridge Runner Road.

Menifee	Cave Run Water Commission	Master Meter Change Out Project	\$39,000	The replacement of six master meters within the system will reduce water loss, and allow better analysis of water production and use.

Montgomery	City of Jeffersonville	Highway 1050 Line Replacement Project	\$129,262.00	This investment will replace approximately 10,000 feet of watermain located along KY-1050 in Jeffersonville. The increase in the watermain along with new valves will improve water pressure and provide additional flow to approximately 350 underserved homes.
Montgomery	Montgomery County Fiscal Court	Judy Water Association Meter Change-Out Proj	\$129,262.00	This project will allow the utility to install radio read meters as needed throughout the water district, improving the efficiency and accuracy of readings, and impacting approximately 1,000 underserved households.

Montgomery	Montgomery County Fiscal Court	Levee Road Water Association Oldham Tank and Mixing System	\$129,262.00	<p>The Levee Road Water Association and Montgomery County Fiscal Court will use this investment to restore and clean a 75,000-gallon water tank located on Oldham Road. A Tideflex Mixing system (or it's equivalent) will also be installed to improve water quality through chlorine residual retention and faster tank turnover. These improvements will impact appoximatley 650 households.</p>
Montgomery	Montgomery County Sanitation District #2	Sewer Collection System Rehab Project	\$129,262.00	<p>These funds will be used to further complete repairs recommended by the Dec. 2021 Sanitary Sewer Evaluation Survey and I & I Study. These will include manhole repairs and replacement, pump station repiars, and sewer line repairs. The project will eliminate sanitary sewer overflows and bypasses, and improve operational efficiency by reducing infiltration of groundwater into the system.</p>

Montgomery	Montgomery County Water District #1	Vault Valve Replacement and Various Waterline Replacements	\$129,262.00	The replacement of a pressure valve, vault and other equipment will help maintain consistent pressure and improve fire protection for approximately 200 underserved households near Whitaker Lane. New water lines in the Lycento Lodge Trailer Park off of US-460 will improve water quality and service for approximately 19 homes. The replacement of the water line and installation of a fire hydrant on Little Joe Street will improve water quality and fire protection for 25 homes in that area.
Montgomery	Mount Sterling Water and Sewer-	Wykagyl/Bridgett Drive Project Phase I	\$129,262.00	This project will replace approximately 1,200 feet of problematic sewer line that is contributing to infiltration of ground and storm water. This first phase will serve approximately 300 customers.
Montgomery	Mount Sterling Water and Sewer	Main Street Water Main Replacement	\$129,262.00	This investment will replace approximately 5,280 feet of aging cast iron waterline, circa 1901, from the entry of old Owingsville Road running along US-60 to Samuels Avenue. The line replacement will improve water quality for approximately 1,500 underserved households. In addition, 16 hydrants will be replaced.

Montgomery	Reid Village Water District	Devonne Pump Station Pump Replacement and Meter Replacement Project	\$129,262.00	Reid Village Water District will replace two pumps located at the Devonne Pump Station to help fill the Devonne overhead storage tank more efficiently. In addition, new radio read meters will be installed throughout the district, greatly increasing the accuracy of readings and quickly identifying water leaks. This project would increase water quality for approximately 500 underserved households.
