



Selected Projects for the Land & Water Conservation Fund (LWCF)

Below is a full list of projects selected by Gov. Andy Beshear to receive funding from the federal LWCF. Each project will undergo review by the National Parks Service for final approval of funding. In total, \$3,966,759 will go to 37 projects in Kentucky.

1. Anderson County

- The Anderson County Fiscal Court will use \$129,103 to build four hybrid tennis/pickleball courts at Anderson County Community Park. The courts will be equipped with lights and lines for pickleball and tennis. The county will also be constructing a parking lot.

2. Bardstown (Nelson County)

- Bardstown will use \$150,000 to develop a vacant lot into a passive park. Sidewalks, landscaping, seating areas, a stage, fencing/columns, a pergola, and a fountain are desired elements for Phase 1 of this project.

3. Bellvue (Campbell County)

- Bellvue will use \$25,000 to expand O'Fallon Park into an adjacent vacant lot. The city will clean the space of overgrown vegetation and add a picnic area including picnic tables and a grill. A path will be paved from Van Voas Avenue into the existing park. Additionally, funds will be used to update the playground equipment.

4. Bourbon County

- The Bourbon County Fiscal Court will use \$100,000 to complete the second phase of development at Bourbon County's court sports facility at the new Bourbon County Park. The scope of work includes the construction of one basketball court, two tennis courts and two pickleball courts.

5. California (Campbell County)

- California will use \$25,000 to replace existing wooden playground equipment with new equipment that meets current safety standards.

6. Carroll County

- The Carroll County Fiscal Court will use \$75,000 to repair an existing footbridge located at Camp Kysoc. The bridge connects two different parts of the property.

7. Carrollton (Carroll County)

- Carrollton will use \$40,000 to purchase and install inclusive playground equipment at Cartmell Elementary.

8. Corbin (Whitley County)

- Corbin will use \$125,000 to purchase and install toddler-aged playground equipment, benches, rubber surfacing and slide mats.

9. Danville (Boyle County)

- Danville will use \$80,000 to replace the existing playground at Butler Drive Park with new playground equipment.

10. Estill County

- The Estill County Fiscal Court will use \$125,000 to improve Kentucky River Park. This will include:
 - 1) Build a new portage and boat ramp to increase accessibility to the Kentucky River.
 - 2) Refurbish the asphalt and nature trails.
 - 3) Construct a fishing dock that connects to the nature trails. Construct a fishing dock that connects to the nature trail.
 - 4) Purchase picnic tables.
 - 5) Construct a splash pad and a shelter with restrooms.

11. Flemingsburg (Fleming County)

- Flemingsburg will use \$102,000 to Purchase and install new playground equipment and improve drainage at an existing ball field at Flemingsburg City Park. They will also purchase and install new playground equipment at Fox Spring Park.

12. Frankfort (Franklin County)

- Frankfort will use \$150,000 to improve East Frankfort Park by replacing an old volleyball court with a basketball court, and adding two tennis courts, three pickleball courts, new lighting, fencing and sidewalks.

13. Georgetown (Scott County)

- Georgetown will use \$250,000 to replace the existing playground structure at Ed Davis Park with new playground equipment.

14. Grayson (Carter County)

- Grayson will use \$187,500 to upgrade the Grayson Sports Complex. This will include:

- 1) The addition of a sensory garden with handicap accessible equipment.
- 2) Construction of an overhead shade structure to the existing park amphitheater.
- 3) Construction of a walking bridge for a creek crossing two adjacent trails. The bridge will connect the trails to provide a one-mile continuous trail.

15. Jackson (Breathitt County)

- Jackson will use \$50,000 to purchase and install new equipment at Douthitt Park's two-to-five-year-old and five-to-twelve-year-old playgrounds.

16. Jenkins (Letcher County)

- Jenkins will use \$66,025 to make renovations to Jenkins City Park. Renovations include:
 - 1) Construct two food booths.
 - 2) Renovate the existing structures and add metal roofing.
 - 3) Upgrade the electricity capacity from 100 watts to 200 watts.
 - 4) Resurface the blacktop area.

17. Lebanon (Marion County)

- Lebanon will use \$63,823 to develop a 1.5-acre fishing area complete with a landscape border of decorative rock, an aluminum pier with a 20-foot wooden walkway and a pier platform located at the end of the walkway. The project also includes the construction of a gazebo, a concrete walkway connecting the new area to the existing sidewalk, an aerator decorative fountain and a woven fence.

18. Liberty (Casey County)

- Liberty will use \$210,566 for construction of a new 8-acre park. The park will feature a group pavilion, vault restroom, two gravel parking lots, an access road with an attached accessible walkway and six primitive campsites complete with parking spaces, grills, fire rings and picnic tables. Utilities will be included.

19. Martin County

- The Martin County Fiscal Court will use \$122,788 to replace the former Martin County swimming pool with a splash park.

20. Mason County

- The Mason County Fiscal Court will use \$75,000 to construct a half mile looped mountain bike trail on the top of the Cummins Nature Preserve. A second quarter mile trail will also be constructed for those that do not want the physical challenges of a

mountain bike trail. The project also includes the installation of a fence, a lookout tower and a restroom facility.

21. Maysville (Mason County)

- Maysville will use \$60,040 in collaboration with the Tom Browning Boys and Girls Club to construct a .91-mile trail around the perimeter of the Club's property.

22. Morganfield (Union County)

- Morganfield will use \$144,625 to build a splash pad, an accessible bathroom facility and a parking lot with nine spaces.

23. Morgantown (Butler County)

- Morgantown will use \$69,000 to construct a trail and trailhead facility. The walking trail will be 1.22 miles long with a width of 5 feet and will be composed of gravel. Grant funds will also be used to construct a restroom facility, parking lot, and install signage, trash cans and benches.

24. Mortons Gap (Hopkins County)

- Mortons Gap will use \$30,000 to purchase and install accessible playground equipment for the city park. The project also includes rubber surfacing and the burial of one utility line.

25. Paducah (McCracken County)

- Paducah will use \$81,885 to replace the existing 30-year-old playground equipment with new inclusive equipment and poured-in-place rubber surfacing.

26. Park City (Barren County)

- Park City will use \$26,838 to build a full outdoor basketball court and outdoor bocce ball court. The basketball court will include four goalposts, two at regulation height and two at wheelchair-access height.

27. Perry County

- The Perry County Fiscal Court will use \$150,000 for improvements to develop a park in Viper **OR** make improvements to Eagles Landing Campground.

28. Princeton (Caldwell County)

- Princeton will use \$250,000 to revitalize two baseball/softball fields at the City-County Park. Fencing needs to be replaced, as well as the dugout structures, bleachers and utility poles for lighting.

29. Raceland (Greenup County)

- Raceland will use \$87,500 to renovate the Raceland City Park. LWCF funds will go toward adding 12 outdoor light posts, 400 square yards of pour in crumb rubber surfacing

and to purchasing and installing four pieces of accessible playground equipment (play structure, swing set, seesaw and merry-go-round.)

30. Southgate (Campbell County)

- Southgate will use \$25,000 to demolish and remove the existing tennis courts. A small park with planted trees, flowers, shrubs and benches will be developed in the area.

31. Taylor County

- The Taylor County Fiscal Court will use \$150,000 to add new LED lighting to four ball fields in Veterans Memorial Park.

32. Tompkinsville (Monroe County)

- Tompkinsville will use \$112,058 to improve Veterans Park. Improvements include:
 - 1) Purchase and install handicap accessible playground equipment and add rubber surfacing.
 - 2) Upgrade existing restrooms and add LED lighting.
 - 3) Purchase and install concession stands, a first aid station and a maintenance building.
 - 4) Repair the boat ramp area.
 - 5) Pave one road.

33. Union County

- The Union County Fiscal Court will use \$100,000 Repave approximately 43,527 square yards of existing roadways and a basketball court at Mofitt Lake Recreation Area.

34. Warren County

- The Warren County Fiscal Court will use \$116,391 to purchase and install play structures and poured-in-place rubber surfacing. A pavilion will also be constructed adjacent to the playground.

35. Webster County

- The Webster County Fiscal Court will use \$128,867 to develop a new county park.

36. Wolfe County

- The Wolfe County Fiscal Court will use \$157,750 for improvements at three parks:

Wolfe County Community Park: Pave the community center parking lot.

Helechawa Park: Construct a new family shelter and basketball court, purchase and install playground equipment, pave the parking lot, add lighting and remove debris from the park.

Hazel Green Park: Purchase and install new playground equipment, pave the walking track, add rubber mulch to the play area and remove park debris.

37. Woodford County

- The Woodford County Fiscal Court will use \$125,000 to build a new picnic pavilion at the Huntertown Community Interpretive Park.
