

Selected Projects for the Recreational Trails Program (RTP)

Below is a full list of projects selected by Gov. Andy Beshear to receive funding from the federal RTP. Each project will undergo review by the Federal Highway Administration for final approval of funding. In total, \$1,125,584 will go to 11 projects in Kentucky.

1. Allen County

The Allen County Fiscal Court will use \$100,000 to construct a 1.82 mile paved walking trail at the new Allen County Park.

2. Bath County

The Bath County Fiscal Court will use \$75,000 to rehabilitate and re-open the Tater Knob Trail (.25 mile) and Tater Knob Fire Tower located in Daniel Boone National Forest.

3. Estill County

The Estill County Fiscal Court will use \$45,000 to extend Estill County's Kentucky River Park asphalt and nature trails, bringing the total trails in the park to 1.5 miles. A fishing dock will connect to the nature trail. This project will also add benches to the asphalt trail and picnic tables at the nature trail. Lastly, funding will be used for a wilderness trail and a camping section.

4. City of Frankfort (Franklin County)

The city of Frankfort will use \$150,000 to build an 8-foot wide, 1-mile-long pedestrian and biking shared-use path along Schnekel Lane, between Bypass Plaza Drive and Northwood Road. The path will join the Indian Hills neighborhood with Cove Springs Nature Preserve.

5. City of Lynch (Harlan County)

The city of Lynch will use \$25,000 to pave the existing Walk of Legends trail with 2 inches of asphalt. The funds will help in the purchase and installment of 10 benches, 4 picnic tables, 1 meter box for lighting, and landscaping.

6. City of Jenkins (Letcher County)

The city of Jenkins will use \$100,000 to design and develop a trail from the Little Shepherd Amphitheater to the Jenkins Combs Overlook. The proposed trail will include

informational signs that detail the history of the mountain terrain, moonshine production and civil war activity.

7. Menifee County

The Menifee County Fiscal Court will use \$200,000 to make improvements to multi-use equestrian and hiking trails located near Cave Run Lake in the Daniel Boone National Forest's Cumberland Ranger District in Menifee County.

8. City of Greenville (Muhlenberg County)

The city of Greenville will use \$55,000 to extend the Muhlenberg County Rails to Trails by an additional and join the trail to the state-of-the-art Ray Jones Family Athletic Complex. The Muhlenberg County Rails to Trails is a six-mile, multi-use, handicapped accessible trail that is paved for hikers, bikers, roller bladers and horseback riders. This unique trail includes a covered bridge, antique caboose and rest areas.

9. Perry County

The Perry County Fiscal Court will use \$80,584 to construct 3.5 miles of hiking and mountain biking trails within the boundaries of the Perry County Park. The project includes the development of an overlook onto KY-15 with a gazebo, picnic tables and primitive camping spots. The project also includes signage.

10. Powell County

The Powell County Fiscal Court will use \$245,000 to make improvements to trails at Hollerwood Off-Road Park.

11. Trimble County

The Trimble County Fiscal Court will use \$50,000 to construct .95 miles of new trails within Trimble County Park, as well as make improvements to existing trails. Improvements include trailhead facilities, footbridges over streams and natural drainage areas, benches, trash receptacles, and signage.
