

# Selected Projects for the Land & Water Conservation Fund (LWCF)

Below is a full list of projects selected by Gov. Andy Beshear to receive funding from the federal LWCF. Each project will undergo review by the National Parks Service for final approval of funding. In total, \$3.9 will go to 32 projects in Kentucky.

## 1. City of Augusta (Bracken County)

• The city of Augusta plans to use \$25,000 to resurface a tennis court and update fencing and nets at the city park.

#### 2. Bath County

• The Bath County Fiscal Court plans to use \$245,000 to build four little league baseball fields. The project will include dugouts, lighting, bleachers, scoreboards, a concession stand, restrooms and asphalt parking spaces.

#### 3. City of Berea (Madison County)

• The city of Berea plans to use \$245,000 to repair the pool at the city park.

#### 4. Boyd County

• The Boyd County Fiscal Court plans to use \$80,600 to construct a splash pad within Armco Park.

#### 5. Breckenridge County

• The Breckenridge County Fiscal Court plans to use \$25,473 to make improvements to the Hardinsburg Sports & Recreation Complex. Enhancements include replacing LED light fixtures surrounding the ballfields and paving the entryway and surfaces under the bleachers.

## 6. Bullitt County

• The Bullitt County Fiscal Court plans to use \$245,000 to repair and update the existing Maryville Park swimming pool for safety and sustainability.

# 7. City of Campton (Wolfe County)

• The city of Campton plans to use \$69,697 to purchase new playground equipment for their city park.

# 8. City of Centertown (Ohio County)

• Centertown plans to use \$25,000 to add swing sets, a pavilion and walking trails to the city park.

#### 9. City of Crescent Springs (Kenton County)

• Crescent Springs plans to use \$245,000 to install new playground equipment at Lou Hartfiel Memorial Park.

#### 10. Daviess County

• The Daviess County Fiscal Court plans to use \$145,808 to improve lighting around recreational fields and courts at Stanley Park.

#### 11. City of Fort Thomas (Campbell County)

• Fort Thomas plans to use \$125,000 to build a skate park in Highland Hills Park.

#### 12. City of Grayson (Carter County)

• The city of Grayson plans to use \$87,500 to install an inclusive swing area to the Grayson Sports Park.

#### 13. Harrison County

• The Harrison County Fiscal Court plans to use \$245,000 to relocate flood-prone baseball fields from River Road Park to Flat Run Veterans Park.

#### 14. City of Harrodsburg (Mercer County)

• The city of Harrodsburg plans to use \$217,730 to build a new playground and install a sprinkler system at Anderson Dean Park.

#### 15. City of Hartford (Ohio County)

• Hartford plans to use \$87,680 to install playground equipment, resurface a basketball court and renovate two baseball fields at Ellis Park.

## 16. City of Hawesville (Hancock County)

• Hawesville plans to use \$161,438 to build a new city park.

#### 17. City of Henderson (Henderson County)

Henderson plans to use \$245,000 to make improvements to Anthony Brooks Park.
Improvements include installing a splash pad, updating play structures and installing restrooms.

#### 18. City of Jackson (Breathitt County)

• Jackson plans to use \$25,000 to buy new bleachers for five playing fields at Kiwanis Park.

#### 19. City of Jeffersontown (Jefferson County)

• Jeffersontown plans to use \$245,000 to help construct an amphitheater at Veterans Memorial Lower Park.

#### 20. Knott County

• The Knott County Fiscal Court plans to use \$130,000 to help rehabilitate several Knott County parks that were damaged by the 2022 flood. Improvements include repairing the basketball and tennis courts, installing playground equipment and ADA swings, landscaping and adding benches, grills, trash receptacles, and picnic tables to Ball Creek Park, Jones Fork Park, Kite Park and Hindman Park.

#### 21. Lincoln County

• The Lincoln County Fiscal Court plans to use \$75,000 to help install pickleball courts in Veterans Park.

## 22. City of Loretto (Marion County)

• Loretto plans to use \$56,780 to improve play structures at the city park. Improvements will include installing inclusive playground equipment, swings with toddler seats and accessible swings.

#### 23. Madison County

• The Madison County Fiscal Court plans to use \$43,506 to update playground equipment at White Hall Park.

#### 24. City of Manchester (Clay County)

• Manchester plans to use \$27,182 for renovations to the Beech Creek Campground. Renovations include resurfacing the existing parking lot and play area, upgrading playground equipment and installing new basketball goals and a bike rack.

## 25. City of Mount Sterling (Montgomery County)

• Mount Sterling plans to use \$245,000 to help construct a natural playground and outdoor amphitheater adjacent to the Adena Walking Trail.

#### 26. Muhlenberg County

• The Muhlenberg County Fiscal Court plans to use \$125,000 to purchase and install playground equipment at the South Carrollton and Millport community parks.

#### 27. City of New Haven (Nelson)

• New Haven plans to use \$50,082 to improve the city swimming pool, purchase basketball goals, add new field tile to the ballfield at New Haven Municipal Park.

#### 28. Owsley County

• The Owsley County Fiscal Court plans to use \$85,497 to build a splash park and walking track in Booneville.

#### 29. City of Paintsville (Johnson County)

• Paintsville plans to use \$245,000 to demolish the existing public pool and construct a splash pad at the site.

#### **30. City of Prestonsburg (Floyd County)**

• Prestonsburg plans to use \$37,000 to resurface, re-stripe, and install new nets at the existing tennis court facilities at Archer Park. One court will be converted into a pickleball court.

## 31. Pulaski County

• The Pulaski County Fiscal Court plans to use \$27,593 to purchase and install playground equipment for children aged 5 through 12 at Pulaski County Park.

# **32.** City of Waverly (Union County)

• Waverly plans to use \$49,031 to update playground equipment at the city park.
