## **School Facilities Construction Commission Awards**

Gov. Beshear presented more than \$47 million in fiscal year 2024-2026 state budget funding for public school facility renovations in SOAR counties. The awards include:

- \$7 million total, \$3.5 million in each fiscal year, to the School Facilities Construction Commission (SFCC) budget unit to be distributed to the Lincoln County School District to support upgrades, renovations and enhancements to the district's facilities;
- \$7 million total, \$3.5 million in each fiscal year, to the SFCC budget unit to be distributed to the Garrard County School District to support upgrades, renovations and enhancements to the district's facilities;
- \$1 million in fiscal year 2024-2025 to the SFCC budget unit to be distributed to the McCreary County School District for middle school and high school campus road construction;
- \$7.1 million to Cumberland County Schools for Cumberland County Elementary School upgrades in fiscal year 2024-25;
- \$12 million to Martin County Schools for upgrades at Inez Elementary School; and
- \$13 million to Rockcastle County Schools for Rockcastle County Middle School.

"Lincoln County Schools will be able to make some great improvements with these funds," said Judge/Executive **Woods Adams**. "Our public school system is a big part of our county in terms of educating students and providing employment to our citizens. We owe a great deal of thanks to our legislators, Rep. David Meade and Sen. Brandon Storm, along with everyone else who made this possible. I also want to thank Gov. Beshear for presenting us with this state budget award, and we are excited to see the impact it will have on Lincoln County."

"We were very excited and appreciative for the collaborative efforts of the House and Senate when we learned about the provision of House Bill 1 that allocated \$3.5 million each year for two years to support school facility upgrades, renovations and enhancements in Lincoln County," said Superintendent **Bruce Smith**. ## **High-Speed Internet Awards**

- Garrard County (799 locations)
- Nicholas County (882 locations)
- Pulaski County (1,904 locations)
- And Robertson County (228 locations)

He also presented South Central Telecom with more than \$1.9 million dollars to connect 809 homes and businesses in Edmonson County.

Combined with matching funds, these awards represent \$68 million dollars in investment in this region, connecting a total of more than 6,790 homes and businesses to high-speed internet. These investments were <u>initially announced</u> last year.
