***Re: Kentucky Superintendents Supporting Pre-K for All***

Dear Senators and Representatives,

As a majority of the superintendents in the Commonwealth of Kentucky, we write urging you to support the Pre-K for All initiative. It would expand Kentucky's voluntary publicly-funded preschool program, so that every Kentucky four-year-old has an opportunity at a strong start.

Our children are facing educational challenges. Fewer than half of Kentucky's kids come to kindergarten ready. We see this in our own classrooms. Children who start behind often stay behind, and it becomes harder and more expensive to help them catch up later. We know expanded Pre-K can change that trajectory. Pre-K for All would make sure every four-year-old in our Commonwealth has the foundation they need to thrive.

At the same time, we know families are struggling to pay the bills and lack of childcare is a key driver. Pre-K for All can help ease the financial burden and boost household earnings by nearly \$9,000 dollars each year for at least six years. That's \$54,000 more dollars in the pockets of our families, cycling through our local economies, creating and maintaining jobs, and growing our communities.

We are in classrooms every day, so we know – **Pre-K works.** But right now, only 14,000 of Kentucky's 54,000 four-year-olds have access to it.

We know from lived experience what numerous studies show - Pre-K improves kindergarten readiness, boosts high school graduation rates, and even raises lifetime earnings after students leave our schools. Families save thousands of dollars, and it fuels workforce participation - raising household incomes and providing more learning opportunities for kids.

Consider the data:

- **Improves Kindergarten Readiness:** Over half – 53.8% – of Kentucky's children arrive at kindergarten already behind. Pre-K for All would close this gap and make sure every Kentucky child has a strong start.
- **Expands the Workforce:** Up to 70,000 Kentuckians are unable to work because they lack childcare. Pre-K for All will let parents reenter the

workforce and take advantage of local job opportunities in our cities and towns across Kentucky.

- **Raises Household Incomes:** A long-term study shows that families with access to Pre-K earn nearly **\$9,000 more per year** - gains that persist for years after their child completes Pre-K.
- **Delivers a 10:1 Return on Investment:** Every dollar invested in Pre-K yields ten dollars in return—from better jobs and health outcomes to reduced criminal justice costs and increased educational attainment.
- **Creates Jobs in Education:** Pre-K for All will generate demand for educators and support staff across the state, creating new careers, and helping attract talent to our towns and cities.
- **Expands Access Across Kentucky:** With 79 of Kentucky's 120 counties having little to no childcare available, this initiative will expand access, create job opportunities, give parents a choice, and lay the foundation for academic success.

As educational leaders, we can say with complete confidence Pre-K for All would be transformative, for our students, our schools, and our Commonwealth. It would help close readiness gaps before they begin, reduce the burden on K-12 intervention services, and build a stronger foundation for every learner across Kentucky.

Our students and their families cannot wait. We urge the General Assembly to make expanding Pre-K access for all Kentucky four-year-olds a top priority in the 2026 Budget Session. Together we can give every Kentucky child a great start, support working families, and invest in a stronger, more competitive Kentucky.

Thank you for your commitment to Kentucky's students and families and for your consideration of this vital initiative.

Dear Members of the Kentucky General Assembly,

As Superintendent of the Bath County Schools I am in support of Pre-K for all from an educational, philosophical, and theoretical stance. The research data supports without question the importance and the impact that Pre-K has on a student's kindergarten readiness. The Commonwealth has offered publicly funded preschool for more than 30 years, currently serving qualifying students with disabilities and those who qualify economically. This roughly is estimated at about 14,500 students of our 54,000 four-year olds in the state or roughly 27% of four-year olds. So, as I mentioned previously I am in support of the Pre-K initiative from the educational, philosophical, and theoretical stances.

After many discussions with other superintendents and school leadership in districts of my comparable size, we are of the mind that we support Universal Pre-K but there will have to be major issues addressed in order for districts to implement. These are the non-negotiables:

- *Facility Needs:* There will have to be adequate funding to address the facility space challenges. As it stands now, our district does not have the space to accommodate the increase in student population to serve and educate that increased number of students. There would have to be increased support for innovative public-private partnerships but also to be aware that in districts in rural areas there may be limited private partners.
- *Workforce Capacity:* There will have to be a pool of qualified early childhood educators and support staff to fill the needs and we will have to have adequate funding for salaries and benefits to effectively compensate these professionals.
- *Operations and Long-Term Sustainability:* There will have to be long-term guaranteed funding streams to sustain expanded preschool programs, maintaining facilities, expanding facilities, and services. There will also have to be additional funding for transportation because additional bus drivers, vehicles, and monitors will have to be employed in order to maximize safety and be compliant legally.
- *Phasing:* Pre-K for all will have to be a phased approach with a tremendous amount of support and guidance to strategically make it an effective program addition rather than a cumbersome mandate.

We all agree that we need to do what is best for our students and their families and universal Pre-K is important for the future success of our students and the Commonwealth. With that acknowledgement, it will have to be fully funded for facility expansion, facility maintenance, availability of qualified teachers and staff, the funding of additional personnel to provide the support services, and be strategically, phased in over a period of years allowing districts time to implement. That means revenue streams will have to be available to many districts years in advance of the first universal Pre-K students coming into buildings.





Dear Senators and Representatives,

I am writing to express strong support for the Preschool for All initiative and to urge your consideration of its long-term benefits for Kentucky's students, families, and communities.

Expanding access to preschool has been a long-standing priority of Kentucky superintendents across decades and administrations. This support reflects a shared, nonpartisan commitment to improving educational outcomes and promoting the wellbeing of Kentucky's children.
