Travel trailers through the Eastern Kentucky Sheltering Program are available to survivors whose homes were majorly damaged, destroyed, or deemed not habitable in one of the eight counties\* designated for FEMA Individual Assistance in the July flooding event. The program will provide temporary shelters to survivors who are unable to locate rental homes or apartments. To be eligible, survivors must register for FEMA assistance, be seeking shelter in their eligible county, and agree to the program terms. For registration by phone, please call 502-234-1225.

## REGISTRATION PROCESS

- Visit the Governor's Flood Resources webpage and click on Eastern Kentucky Sheltering Program.
- Enter the information requested, including your name, pre-disaster address, and the number of people in your household.
- To be eligible, you must register for assistance with the Federal Emergency Management Agency (FEMA).
- After submitting your registration, you will be contacted by a Commonwealth official.

## ELIGIBILITY & SITE REVIEW

- Kentucky Emergency Management staff will review your eligibility for the program.
- If approved, you will be required to sign occupancy documents.
- If eligibility requirements are met, your household will be assigned a shelter.
- Eligibility for continued sheltering in your travel trailer will be renewed on a consecutive, 30-day basis.

## TERMS & CONDITIONS

The program terms include agreement to the following conditions:

- Release of personal information to the Commonwealth, FEMA and volunteer organizations to provide assistance.
- Accept responsibility for any damage caused to state property during your stay in the assigned shelter.
- Understand this is temporary shelter and is actively working towards permanent housing.

\* Eligible counties: Breathitt, Clay, Floyd, Knott, Leslie, Letcher, Magoffin, Martin, Owsley, Perry, Pike, and Whitley Counties.

## **FREQUENTLY ASKED QUESTIONS**

### **Who can apply for the Eastern Kentucky Sheltering Program?**

The Eastern Kentucky Sheltering Program is available to provide temporary shelter for survivors from the eight counties (Breathitt, Clay, Floyd, Knott, Leslie, Letcher, Magoffin, Martin, Owsley, Perry, Pike, and Whitley) declared for FEMA Individual Assistance in the July floods. To be eligible for the Eastern Kentucky Sheltering Program, survivors must be registered with FEMA; seeking shelter in their eligible county; have a primary residence that is majorly damaged, destroyed, or not habitable; and agree to the program terms.

### **What does it cost to participate in the program?**

This program is sponsored by the Commonwealth of Kentucky and provides sheltering units to eligible survivors for free.

### **Am I eligible if my home was damaged in a disaster other than the July Floods?**

No. The Eastern Kentucky Sheltering Program is specifically for survivors of the July floods.

### **Am I eligible if I have homeowners or renters insurance?**

If you have insurance, have your insurance claim and registered with FEMA, and still need temporary sheltering assistance, you may be eligible. Complete your registration and continue to work with FEMA, insurance, and other available resources on your recovery options.

### **What is a commercial site?**

A commercial site is a public location where two or more households will be sheltering in their own individual travel trailer units. The site may currently be used or have previously been used as a RV park or a manufactured housing community.

## **DUTIES OF TRAVEL TRAILER OCCUPANTS**

- Occupant signs Release of Information Agreement, Right of Entry Agreement and Revocable License for Occupancy documents.
- Occupant must agree to eligibility review every 30 days for continued occupancy.
- Occupant must work to establish a permanent housing plan following travel trailer occupancy.
